RAFFLE RULES AND REGULATIONS

1. This raffle is conducted by the Leonard and Betty Jo Galati Foundation DBA Helping Heroes, located at 342 Raleigh Street, Holy Springs, NC 27540. Helping Heroes is a non-profit organization under Internal Revenue Code Section 501(c)(3) and as defined by Chapter 55A of the North Carolina General Statutes.
2. The raffle will be conducted from March 1, 2023, to August 1, 2023, with tickets available for purchase while quantities last through August 1, 2023. Helping Heroes reserves the right to sell a limited number of tickets on the day of the drawing if any are available.
3. A maximum of 1,000 tickets will be sold at \$20 per ticket. The odds of winning are dependent on the number of valid entries up to 1,000.
4. Purchasers of tickets must legibly write their name, address, phone number and email address (if applicable) on the ticket.
5. If more than one name is listed on the ticket, the first name listed shall be considered the “entrant.” Helping Heroes shall, will and can have no obligation for delivery of any prize to any person other than the entrant.
6. Minors may not purchase or have their names identified as entrants. Raffle is only open to U.S. Residents.
7. Participants need not be present to win.
8. Helping Heroes employees, members of the Board of Trustees, authorized agents thereof, consultants, attorneys, independent account firm and their spouses and children living in the same household are excluded from participating and are not eligible to win.
9. Payment for the tickets shall be made in “good money” which may be cash, check, credit card or debit card. Checks should be made payable to “Helping Heroes” If any purchaser’s check is dishonored by the bank, the raffle ticket will be declared invalid unless and until full payment in “good money” is made prior to the drawing. All purchases are final, and no refunds will be issued.
10. Winner will be picked by random drawing on August 4th, 2023, and we will attempt to contact the winner after the drawing.
11. Winners agree to allow use of their name and likeness for publicity purposes without compensation.
12. Prize to be given away in the raffle is: One guided buffalo hunt to include two days, one night, food and lodging, field dress, caped hide, meat processing by Mountain Meats, guide tip, and transportation to and from the Grand Junction airport to the ranch., valued at \$12,500.
13. The winner will be contacted by Helping Heroes staff, who will help schedule or deliver raffle prize. When claiming their prize, the winner shall provide one form of picture identification.

14. Winners acknowledge that Helping Heroes, its Staff, Volunteers, Officers, its agents and representatives have not made, and neither are they in any manner responsible or liable for any warranty, representation or guarantee expressed or implied in fact or in law, relative to any prize, including but not limited to its quality, mechanical condition or fitness for a particular use.
15. If the winner cannot be reached at the phone number, email address or mailing address on the ticket stub for any reason by August 19, 2023, a disqualification will result, and an alternate winner will be drawn.
16. Helping Heroes staff, and members of the Board of Trustees, are excluded from participating and are not eligible to win the drawing.
17. The decision of the President & CEO and the Board of Directors of Helping Heroes shall be final on all matters concerning the raffle.

TICKETS

Tickets are \$20 each. Only one method of payment, one name, and one mailing address are permitted per ticket pack. Only one eligible person may be entered in the raffle per ticket sold. If the name of more than one person is submitted with a ticket purchase, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of prize by a group purchasing a ticket in common shall be to the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner. Helping Heroes reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds". All defective or physically altered entry forms will be immediately disqualified by Helping Heroes. Prior to the drawing, Helping Heroes will make a reasonable effort to notify the individual and/or entity that submits such an entry form or one which has been rejected because the credit card or check did not clear and that the entry has been rejected by attempting to make contact

through the information provided at the time of submitting the purchase request. All orders for tickets must be received and/or purchased by the indicated deadline. Helping Heroes assumes no responsibility for lost, late, misdirected or non-delivered mail or fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

No refunds will be made except under the following circumstances: any ticket order with payment received after 1,000 tickets have been sold or after August 1, 2023, will be returned. No other refunds are available except at the exclusive discretion of Helping Heroes. Helping Heroes assumes no responsibility for lost, late, misdirected or non-delivered mail or fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.
